DEED OF VARIATION TO THE FUNDING AGREEMENT

THIS DEED is made the 29 day of JANUARY 2024

BETWEEN

- 1) The Secretary of State for Education (the "Secretary of State");
-and-
- 2) The Bradford Academy Trust, (the "Company") [a charitable company incorporated in England and Wales with registered number 05508735, together, the "Parties".

INTRODUCTION

- A. The Parties entered into a funding agreement dated 10th August 2005 (the "Funding Agreement") relating to the establishment, maintenance, and funding of an Academy in accordance with the Funding Agreement. A copy of which is contained in Schedule 1 (the "Existing MFA"). A subsequent amendment dated 26th October 2018, a copy which is contained in Schedule 2 ("Amended Master Funding Agreement").
- B. The Parties now wish to vary and amend certain terms and conditions of the Funding Agreement in accordance with the terms of this Deed. A copy is contained in Schedule 3 ("Amended Master Funding Agreement").
- C. This Deed is supplemental to the Funding Agreement.

1. INTERPRETATION

1. 1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Funding Agreement.

2. VARIATION OF THE FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Funding Agreement shall be amended as follows:

Section 2.10 - A Resourced Provision of a Social, Emotional and Mental Health (SEMH) unit serving up to 24 places.

Section 5.13 - Confirmation of the acquisition of the Lease of Land (previously a tenancy at will) from Bradford Metropolitan District Council, Land Registry number YY177911, dated: 22.09.2022.

- 2.2 Except as varied by this Deed, the Funding Agreement shall remain in full force and effect.

3. Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and

construed in accordance with English law.

- 3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. Counterparts

- 4.1 This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
